

**INTRODUCTION** Agricola Mining was granted Exploration Licence 3791 in June 2007. The area covered farmland at Kongorong 20 kilometres southwest of Mount Gambier in the South East of South Australia. This area is shown in **Figure 1**.

**EXPLORATION** A field trip was made in May 2007 to investigate the old limestone quarries in the Kongorong area. Most abandoned quarries were found to contain flint nodules which are a contaminant and which render the limestone unsuitable for agricultural or industrial purposes. However one quarry southeast of Kongorong village was found to be flint free.

This quarry was pegged as a Mineral Claim under Miners' Right 8222 in mid 2007. Mineral Claim 3829 was then registered on 28 August 2007.

A MARP was prepared as part of a Mineral Lease application which was lodged with Mineral Tenements in November 2007. An offer of a Mineral Lease was made to Agricola Mining by Mineral Tenements on 18<sup>th</sup> April 2008. This ML covers 15.4 hectares and is on Section 437, Hundred of Kongorong.

**ANALYSIS** One sample was analysed from the disused quarry within MC 3829. Analysis was carried out by Unimin of Lilydale, Victoria. Results were :-
