Geothermal licences (GEL) 294 & 295 were granted on 8 February, 2008. These licences were renewed for a further 5 years. The licences are located in the Spencer-Lake Torrens Region, South Australia. This report details the work conducted during Licence Year 3 of the Licence (08/02/2019 – 07/02/2020 inclusive), in accordance with Regulation 33 of the Petroleum and Geothermal Energy Act 2000.
