No field work was undertaken on this tenement for the year to 25 October 2001 and consequently there is no technical data to report.

We remain very committed to the potential of our exploration holdings (including those of Alphadale Pty Ltd) in the Curnamona Craton. This includes in addition to this licence EL 2662 Billeroo West, EL 2812 Benagerie, EL 2225 Emu Dam and EL 2616 Eurinilla. Our commitment is evidenced by the substantial expenditure of over \$14 million on our Benagerie Ridge Joint Venture in recent years. Approximately \$1 million has been spent to date on the Lake Charles and Billeroo West tenements. The Lake Charles Magnetic Complex within EL 2560 is very similar in appearance to the Benagerie Ridge Magnetic Complex and given a more favourable exploration regime than has been the fact over the past few years we are confident we would have been able to attract a joint venture party to further explore this tenement.

We believe there is a change taking place with respect to exploration in the investment markets in part no doubt due to the reported successes elsewhere in South Australia. This change along with initiatives we are implementing ourselves we hope will lead to a renewed interest in this tenement. We are currently in discussion with a number of parties with respect to our Curnamona holdings and are hopeful that this will lead to the appointment of a joint venture partner to invest in exploration in this licence.

We remain very committed to the potential of our exploration holdings in the Curnamona Craton. This includes in addition to this licence EL 2664 Billeroo West, EL 2812 Benagerie and EL 2878 Emu Dam. Our commitment is evidenced by the substantial expenditure of over \$14 million on our Benagerie Ridge Joint Venture in recent years. As you may be aware we are in the process of purchasing Pasminco's 70% share of this Joint Venture and that will result in our holding 100% title to a large contiguous area of high exploration potential in the Curnamona.

Approximately \$1 million has been spent to date on the Lake Charles and Billeroo West tenements. The Lake Charles Magnetic Complex within EL 2560 is very similar in geophysical appearance to the Benagerie Ridge Magnetic Complex.

We have had discussions with a number of interested parties with respect to our Curnamona holdings but further developments are pending finalisation of arrangements with Pasminco. Progress is being made but for reasons unknown to ourselves it is a very slow process. We are confident that completion of the purchase from Pasminco will allow us to select a joint venture partner to invest in the Curnamona including exploration of the Lake Charles licence.
