1 Introduction

Gas Storage Exploration Licence No. 645 (GSEL 645) is located in the Cooper Basin, South Australia.

The Annual Report details the work conducted during Licence Year 2 which corresponds to the period 15 October 2015 to 14 October 2016. This Annual Report has been prepared in accordance with the requirements of Regulation 33 of the Petroleum and Geothermal Energy Act 2000 (the Act).

2 Licence Summary

GSEL 645 was granted on 15 October 2014 for a period of five years to

Beach Energy Ltd (Operator) 15%
 Great Artesian Oil and Gas Pty Ltd 45%
 Drillsearch Gas Pty Ltd 30%
 Rawson Resources Ltd 10%

The area of GSEL 645 overlays the area covered by PRL 26 (Udacha Unit) in the Cooper Basin.

The licence condition 1 for the first term of GSEL 645 requires the licensees to carry out the following approved work program

3 Regulated Activities

Pursuant to Regulations 33(3)(a) An annual report must include "a summary of the regulated activities conducted under the licence during the year"

No regulated activities were undertaken in GSEL 645 during the reporting period.

4 Compliance Issues

Pursuant to Regulations 33(3)(b) & (c) An annual report must include -

4.1 Licence and Regulatory Compliance

There were no incidents of non-compliance with the Act, the Petroleum and Geothermal Energy Regulations 2013 (the Regulations) or the Licence Conditions for GSEL 645 during the reporting period.

4.2 Compliance with Statement of Environmental Objectives (SEO)

As no on ground activities were undertaken during the reporting period, there were no instances of non-compliance with the SEO.

5 Management System Audits

Pursuant to Regulation 33(3)(d) An annual report must include-

"a summary of any management system audits undertaken during the relevant licence year including information on any failure or deficiency identified by the audit and any corrective actions that has, or will be taken".

Mapping of Beach's operational regulatory compliance commenced in 2016. This has resulted in various actions targeted at improvements in systems, workflows and reporting methods.

Over the past year Beach has instigated a process of conducting internal audits/assessments of its application of the HSE system. These are addressed as part of annual HSE system objectives which are reported upon quarterly. Any actions, as result of these audits, are internally monitored through an enhanced It system called CMO.

A total review of the current HSE Procedures has commenced within 2016. The intent of this review is to align the HSE procedures with current Beach requirements as well update any appropriate references.

Beach continues to utilise Field HSE Advisors to assess and monitor the application of HSE systems in its operations as well as the HSE systems standards of its contractors.

Any contractors engaged to undertake activities for Beach operations have their HSE systems audited prior to commencement and also monitored on an ongoing basis.

An emergency exercise relative to Beach Energy's Drilling operations was conducted in late 2015 to test the efficiency of these teams of the Emergency Management procedures. Ongoing quarterly emergency exercises continue to be undertaken in Beach's field operations.

6 Report and Data Submissions

7 Incidents

Pursuant to Regulation 33(3)(f) An annual report must include -
